

Boundary Approach

Basic knowledge of where the product is sourced from (same as minimum approach + maps or GPS point for estates/smallholders/small growers and catchment area for dealers)

Full Approach

Full understanding of where exactly the product is sourced from



Definitions

Engaged

To engage a supplier on the compliance of company requirements means that a representative of the company has explained to the supplier the requirements needed for them to supply their product to the company.


Assessed - T
