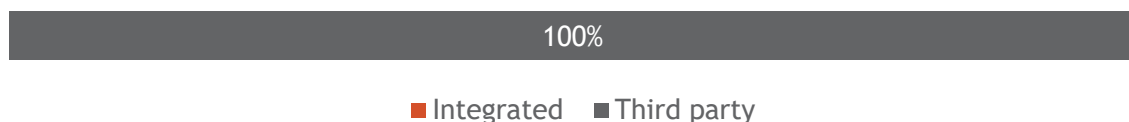

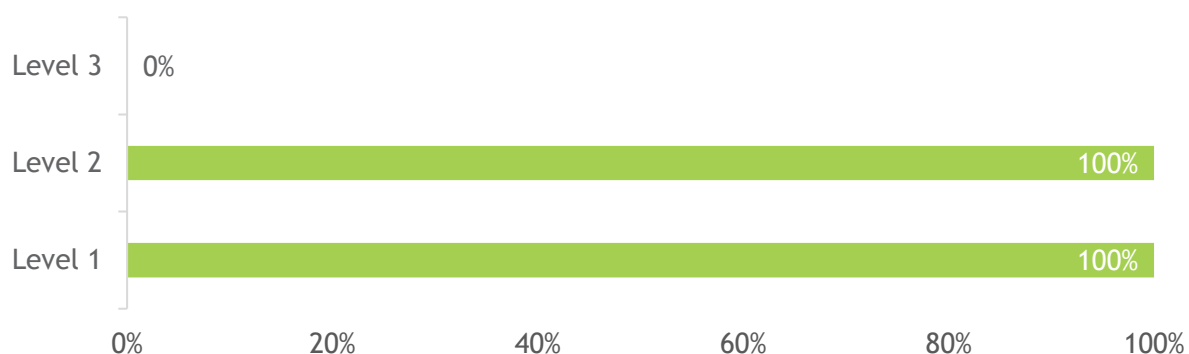

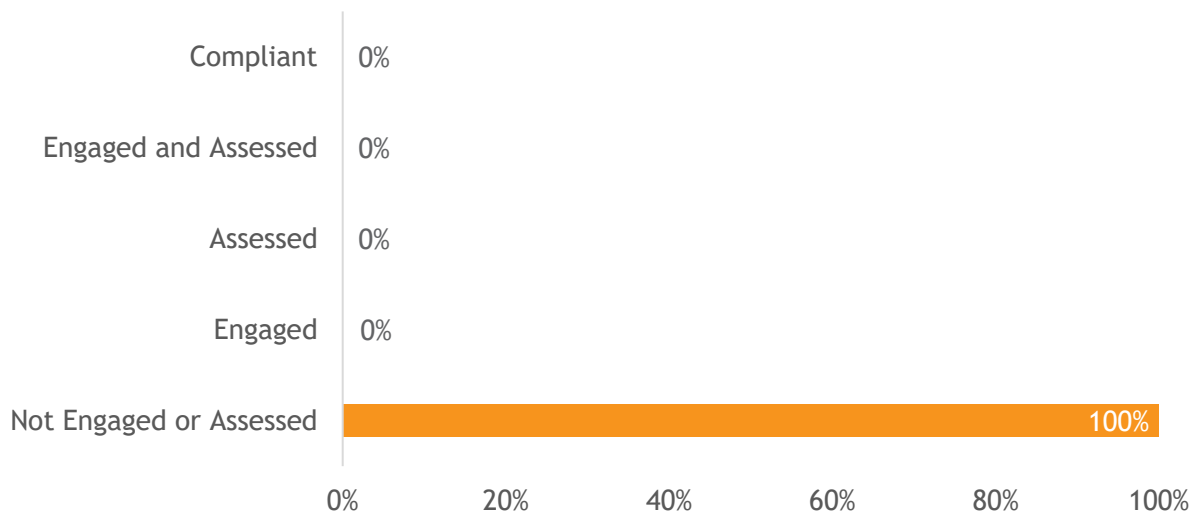
Definitions

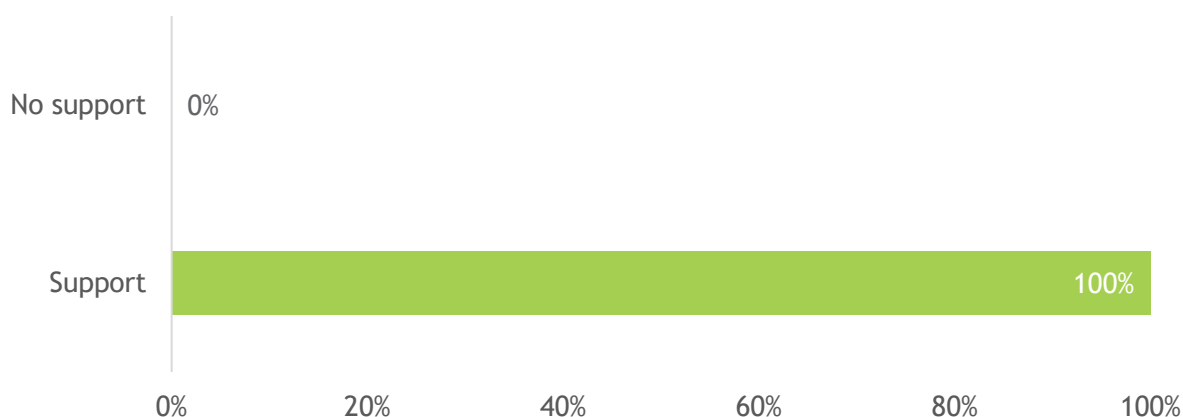
Definitions
