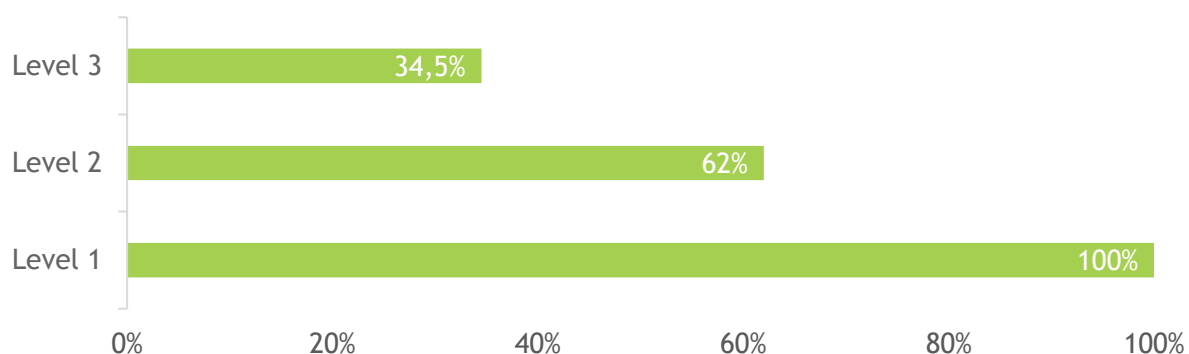

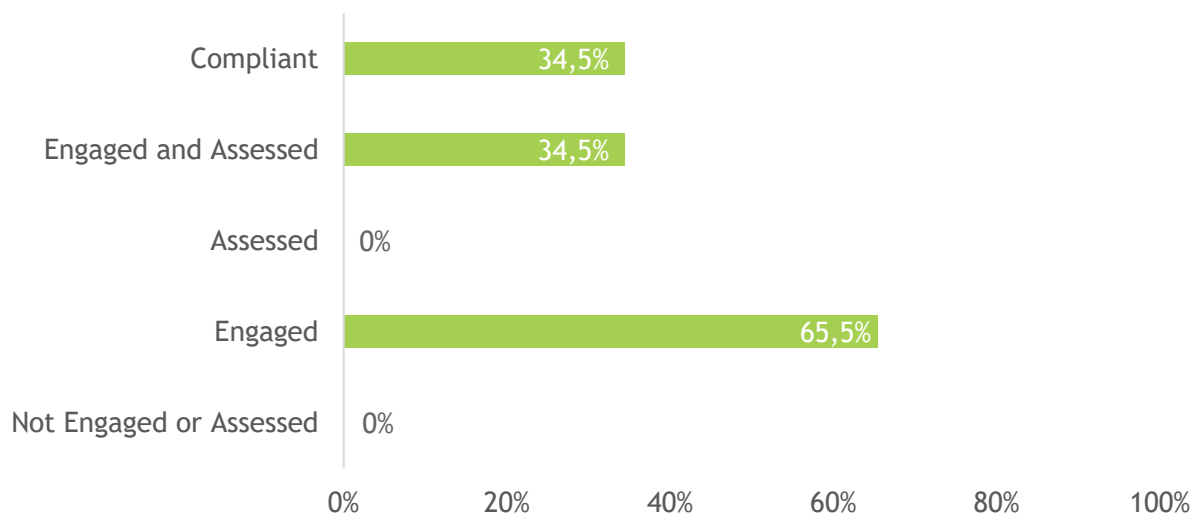
Definitions

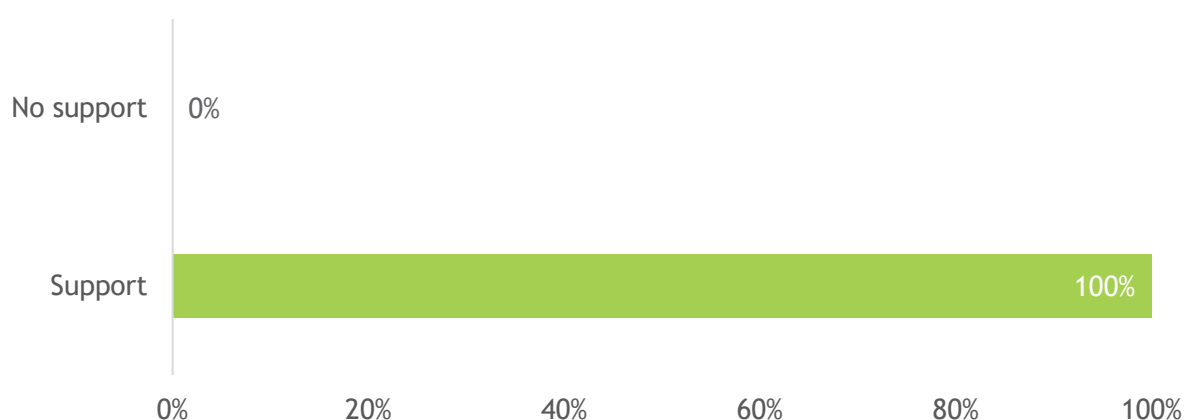
Definitions
