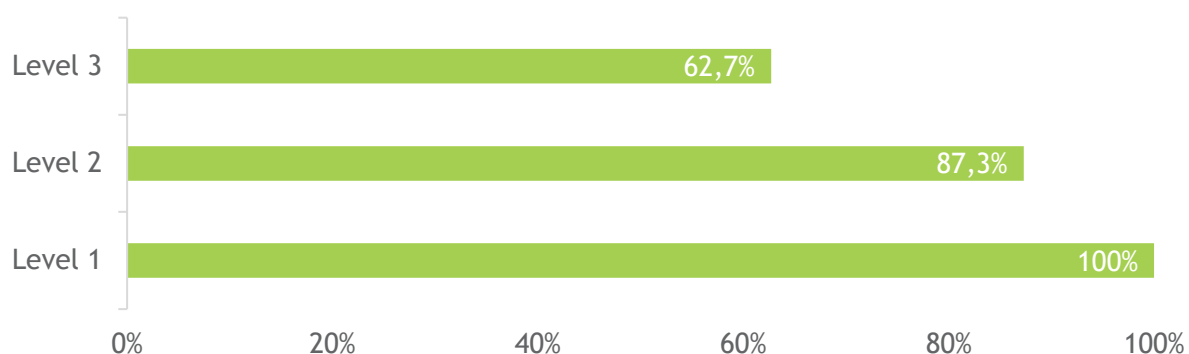

FFB Traceability



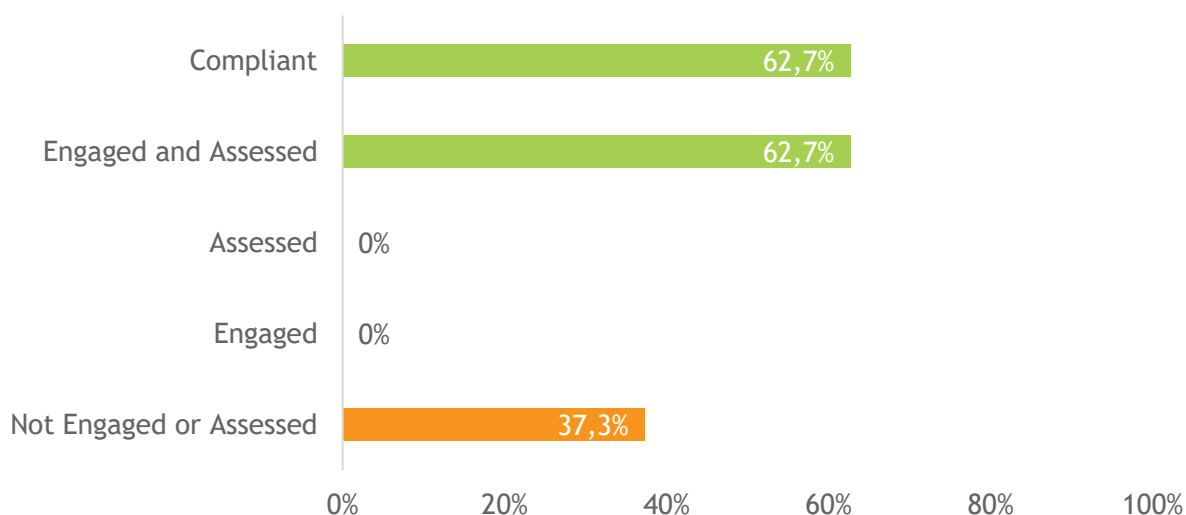
Definitions

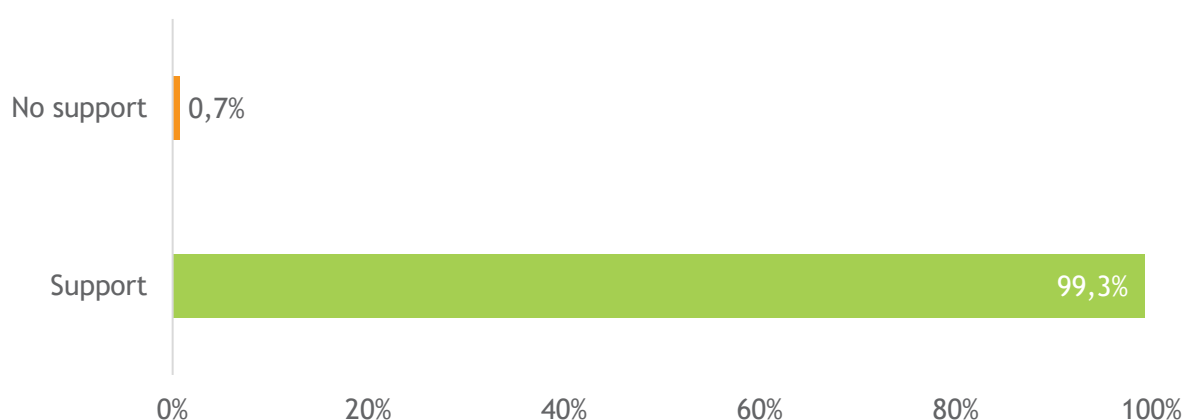
Definitions
