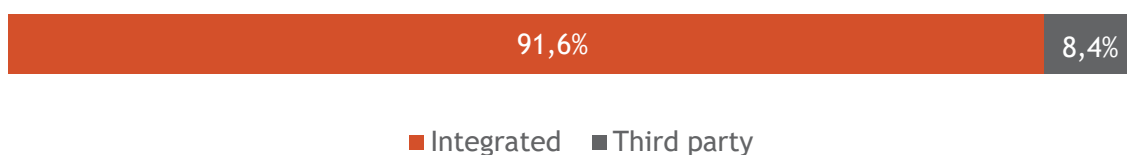

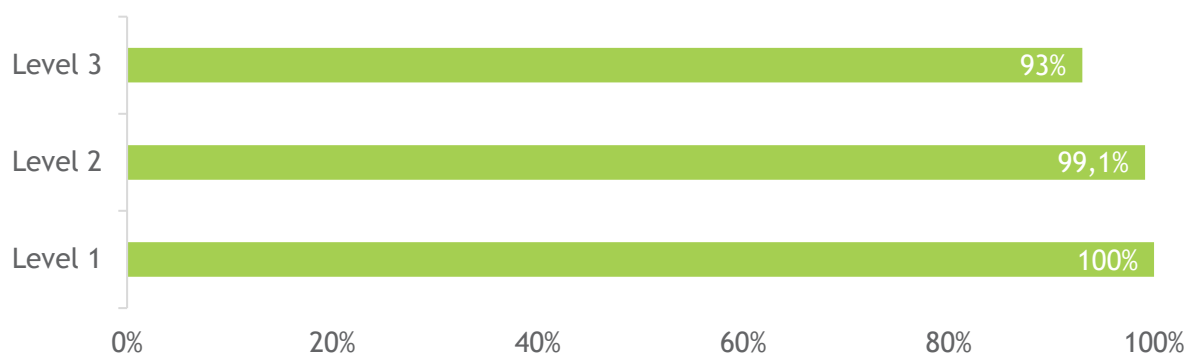

### FFB Traceability



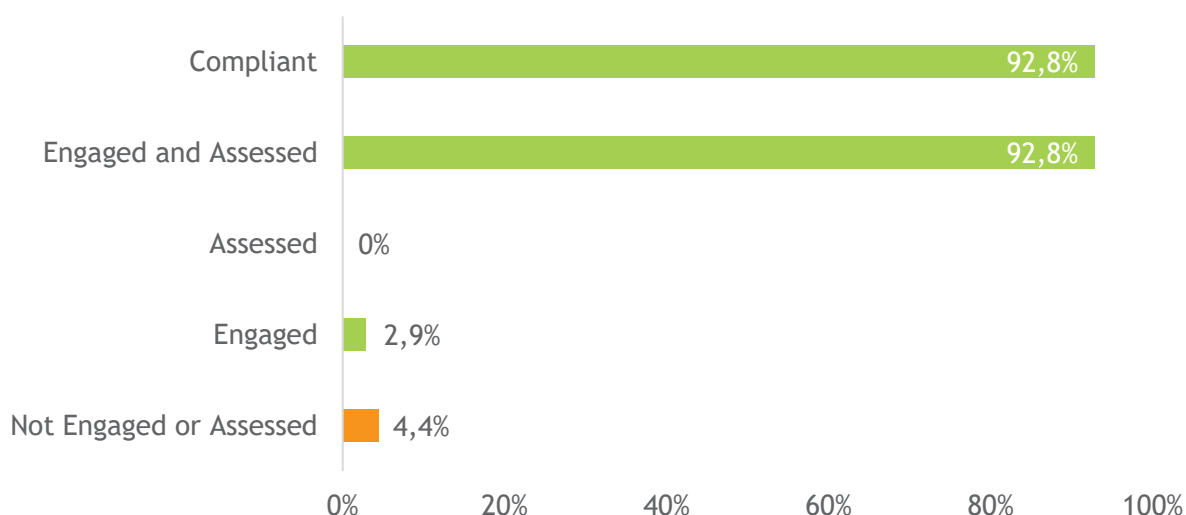
## Definitions

- Level 1: Identification of suppliers (names).
- Level 2: Same as level 1 and precise localization of the industrial plantations with maps, localization of the smallholders with GPS points, catchment area for the dealers.
- Level 3: Same as level 2 and maps of all the smallholders' plots, who deliver directly to the Socfin oil palm mill or through dealers.

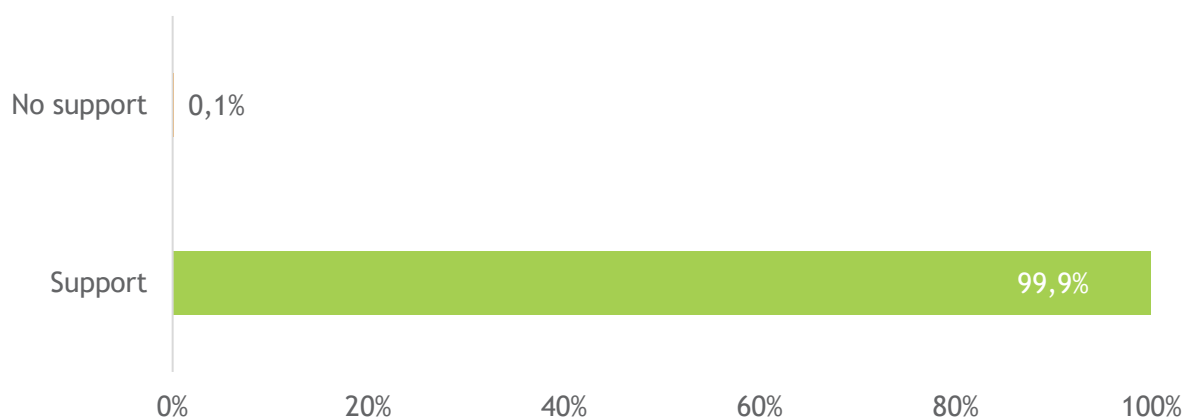
### Definitions

- Compliant:** To be compliant to the Socfin Responsible Management Policy following an assessment.

## Definition
